Special Meeting – August 18, 2015

The Jasper City Council of the City of Jasper met in said city, August 18<sup>th</sup>, 2015 at the Jasper City Office. Council members present: Mayor Mike Baustian, Lisa Rodman, Pete Johnson, Karen Damman & Jeff Leslie; Employees present; Clerk-Treasurer Cortney Kounkel; *Jasper Journal's* Kyle Kuphal;

This special meeting was called by Mayor Mike Baustian for the 2016 Budget. Kounkel developed a draft copy of a budget for 2016. Council members discussed each line item. This will be reviewed at the September 15, 2015 prior to approval.

Items discussed for the 2016 budget (effective 1-1-16) included:

- -RV Park Fees will be dropped in ½;
- -ATV Expenses dropped to \$2000.00;
- -Pipestone County Fines dropped to \$500.00;
- -Interest Earnings dropped to \$2000.00;
- -City Float Contributions will be set at \$1000.00;
- -Full-time employee salaries (Brian & Chuck) increased to \$40,000.00;
- -Workers Comp Ins. Premium was increased to \$12,000.00;
- -Kounkel to look into General Liab. Insurance + Volunteer;
- -Electrical Utilities decreased to \$5000.00;
- -Kounkel to look into Refuse Collection for all buildings;
- -Dues, permits & Fees increased to \$2500.00;
- -All Employee Payroll Payable was increased by 51%;
- -Council salaries to remain the same;
- -Increase Amb. Workers Comp to \$3750.00;
- -Increased Fire Dept. FICA contributions to \$850.00;
- -Increased Fire Dept. Workers Comp to \$3600.00;
- -Kounkel to look into Fire Dept. phone;
- -Increased Park Shelter repairs to \$5000.00;
- -Increased Cleanup day expenses to \$2500.00;
- -Increased Amb. Operating supplies to \$2000.00;
- -Kounkel to look into Amb. Personal Recruitment;
- -Amb. Telephone expense increased to \$750.00;
- -Street Assessment payments decreased to \$30,000.00;
